Conditions

- 1. Upon customer acceptance agreement price is due.
- 2. Customer will receive two check and services on 1, 2, or 3 units (whichever applies) per year.
- **3.** This agreement entitles the customer to 10% off all parts and labor. This excludes freon and diagnosis fee for one year.
- **4.** This agreement shall be in effect for one year from the date of customer acceptance.
- **5.** Services will be performed during normal working hours only.
- **6.** All repair work shall be brought to the customer's attention for customer authorization.
- **7.** Repair changes necessary to correct defects discovered during maintenance inspections will be the sole responsibility of the purchaser.
- **8.** This agreement is transferable to a new homeowner when 30 days written notice is given.
- 9. The terms of this agreement shall be renewable upon payment, unless canceled by either party, but subject to price revision on any anniversary date. All renewals are due on either March 1st or September 1st.
- 10. This agreement may be terminated upon nonpayment of any amount when due. Notification will be made of any payment which is not received when due and if payment is not made within 10 days from the date of such notice, this agreement shall automatically cease as of that date, and we shall have no further obligation of any nature whatsoever.
